2013 Benchmarking Survey



NPTC has released its 2013 Annual Benchmarking Survey, which examines a number of private fleet related issues and is designed to validate private fleet performance based on comparative peer data; to identify areas of improvement and opportunity; and to highlight significant trends affecting private fleet practitioners. Working together with a Benchmarking Steering Committee, NPTC staff

designed and updated a 75question survey that was emailed to all NPTC Feet Member companies. Preliminary information was presented on May 1 at the Benchmarking Summit, where industry professionals divided into operationally distinct group to scrub and refine the data. A total of 93 companies participated in the survey.

The survey delved into key operational, safety,

technology, equipment, maintenance and labor metrics. One of the primary take-aways is that private fleets remain incredibly buoyant about the future. Fully two-thirds of the respondents reported that their private fleet would grow or handle more of its company's freight over the next five years.

Mari is currently the Director of Transportation Optimization and Technology for Frito-Lay North America, based in Plano, TX headquarters. Frito-Lay is the division of PepsiCo that manufactures, markets and sells corn chips, potato chips and other snack foods. In her present role, she and her team are responsible for the transportation optimization, network efficiency and technology solutions for the company's 31 traffic centers in the US and Canada.

Mari studied Supply Chain Management at Arizona State University, where she grew fascinated by the logistics/transportation sector of the industry. She began her career at the Casa Grande Plant in Arizona where she served as Network Resource and then Traffic Manager.

"Coming out of college, I had an immediate respect for the Frito-Lay drivers and I wanted to make a difference for them," she recalls. "Plus, they all had bets I wouldn't last more than 6-12 months so I had to stick around to prove them wrong!
