# **Awards and Recognition**

# **Professional Leadership Awards**

Each year, in conjunction with the NPTC's Annual Education Management Conference and Exhibition, NPTC recognizes six executives for their impressive contributions to the private fleet community during the group's Annual Conference. Since 1990, the Private Fleet Professional Leadership Awards have recognized those individuals who have made significant contributions to the National Private Truck Council, their profession, and the private trucking community.

#### Daniel P. Smith Life Achievement Award

Named after former NPTC Board Chairman Daniel P. Smith, this award is presented to an individual who has made significant leadership contributions to the NPTC in helping advance the goals and objectives of the Council, and whose personal traits of honor, integrity, tenacity and devotion to duty in making these contributions serve as a exemplary model for future NPTC-member private fleet professionals.

#### **National Driver All-Stars**

Co-sponsored by International Truck/Navistar, the National Driver All-Stars is a program that recognizes drivers who have demonstrated high performance standards against their peer drivers throughout the country based on customer service, safety, adherence to company standards, regulatory compliance, and community service.

#### **Driver Hall of Fame**

Each year, NPTC inducts four drivers into the NPTC Driver Hall of Fame, sponsored by Bridgestone Bandag Tire Solutions, during the Annual Education Management Conference and Exhibition. The drivers are from NPTC member companies and have met the minimum qualifications of 20 years, two million miles or 50,000 hours of driving without a preventable accident. Since its inception, 96 drivers have been installed in the Driver Hall of Fame.

# **Fleet Safety Awards**

Sponsored by NPTC and Bridgestone Bandag Tire Solutions, these awards are presented to those companies whose fleets experienced the lowest ratio of accidents per million miles for the past year. In addition, the awards recognize fleets for outstanding and/or improved safety records based on their crash rates.

# **Excellence in Backhauling Award**

The award, co-sponsored by NPTC and C.H. Robinson Worldwide, recognizes the fleet that has improved efficiency and operational performance by making demonstrable improvements in lowering its empty backhaul ratio and increasing its loaded miles.

# **Legal and Regulatory Advice**

Government officials are particularly interested in the NPTC perspective on transportation issues because our members represent the largest and best practitioners of truck safety. NPTC is your connection to key legislators on issues that directly impact your fleet operations. NPTC members also enjoy direct access to Mr. Schweitzer for his free legal advice.

### **NPTC's Washington Report**

The NPTC Washington Report features Rick Schweitzer, NPTC's General Counsel and Government Affairs Representative, giving the latest update on key legislative and regulatory compliance issues of interest to private fleets, and serves as the monthly teleconference meeting of the NPTC Legislative and Regulatory Advisory Committee.

#### Sleep Apnea Resource Guide

Sleep apnea is one of the most serious safety issues confronting the trucking industry. NPTC has established a Task Force to help provide private fleet members with educational information about this subject by creating a heightened state of awareness of why sleep apnea should command management attention and action; to identify and recommend (where appropriate) best practices and standards in managing a sleep apnea program for drivers without NPTC actually endorsing or promoting the programs and services of any Allied/Supplier members; and to potentially help shape FMCSA regulations on sleep apnea by sharing with the agency the successful programs voluntarily put in place by private fleet companies.
