2016 BENCHMARKING SURVEY

This year's Benchmarking Survey Instrument has been sent to the Benchmarking Steering Committee for review. The survey was sent to the general membership in February. NPTC conducts an annual Private Fleet Benchmarking Survey, sponsored by PeopleNet, designed to validate private fleet performance based on comparative peer data, identify areas of improvement and opportunity, and identify the significant trends affecting private fleet practitioners. The final report will be released August 1, 2016.



CTP EXAM

On Saturday, February 13, 66 candidates sat for the Certified Transportation Professional exam in 32 proctored locations. In addition, 18 CTPs volunteered to grade the case study and short answer essay portions of the exam on February 22-23 in Jacksonville.
