PRIVATE FLEET MANAGEMENT ONLINE

BENCHMARKING SURVEY

The benchmarking survey has been sent out to NPTC fleet members. The annual Private Fleet Benchmarking Survey conducted by NPTC and sponsored by PeopleNet is designed to (1) validate private fleet performance based on comparative peer data, (2) identify areas of improvement and opportunity, and (3) identify significant trends affecting private fleet practitioners.

This survey is designed for the benefit of our members and the private fleet community. The purpose of the survey is to help members benchmark their operation to other best-in-class performers, thereby validating performance and identifying areas of opportunity.

A preliminary report will be presented at the Benchmarking Summit at the annual conference, and the final report will be released in August. The report is free to all registrants of the annual conference.
