NPTC recognized seven executives for their contributions to the private fleet community during the group's recent Annual Education Management Conference and Exhibition.

The Dan Smith Life Achievement Award, the Council's highest and most prestigious honor, was awarded to Tony Jolly, CTP, national manager of dry transportation operations-retail, General Mills. The NPTC Excellence in Membership Award went to Keith A. McWilliams, CTP, regional transportation manager for Kellogg Co. The Allied Member of the Year was presented to Fleet Advantage. The NPTC/C.H. Robinson Worldwide Excellence in Backhauling Award was given to Ashley Distribution.

NPTC ANNOUNCES LARGEST EVER GRADUATING CTP CLASS

Ninety-three transportation professionals achieved the prestigious designation of Certified Transportation Professional® (CTP) by the NPTC Institute, the educational and professional certification arm of the NPTC. The graduates were honored during a ceremony at its recent annual conference. Each year, *Fleet Owner* sponsors the CTP Top Graduate Award. This year's award was presented to Bradley Johnston, CTP, transportation manager for Kellogg Co.

NPTC PRIVATE FLEET SAFETY AWARDS

The National Private Truck Council recognized those fleet members who continue to elevate safety performance during the group's Annual Education Management Conference and Exhibition recently held in Cincinnati.

The NPTC/Lytx Inc. Fleet Safety Awards program recognizes NPTC member companies that work to make safety a priority in their private fleets' operations.Following are the 2015 winners (based on safety performance achieved in 2014):

□ Local operations (fleets whose vehicles deliver in a local market regardless of size)—Dominion Virginia Power (first place, tie); Blain Supply Inc. (first place, tie); American Proteins Inc.(third place)

□ Regional Operations—TMH Transport LLC (first place); AEP Industries Inc. (second place); Contract Transportation Systems/Sherwin-Williams Co. (third place)

□ Mixed operations (small fleet – less than 50 vehicles)— Metal Exchange Corp. (first place); Sugar Foods Corp. (second place); Marzetti Co. (third place)

□ Mixed operations (large fleet – 50 vehicles or more)—Baxter Healthcare Supply Chain (first place); New South Express Inc. (second place); Orscheln Farm and Home LLC (third place)

Also recognized were those fleets with outstanding and/or improved safety records based upon their crash rates. Winners of the Gold Seal, awarded to fleets that experienced zero crashes in 2014, include ADM Alliance Nutrition, ADM Trucking Inc., AEP Industries Inc., Cooper Tire & Rubber Co., CVS/Caremark, Targa Transports LLC, and Upstate Niagara Cooperative.

Winners of the Silver Seal, presented to those companies whose fleets reduced their vehicle crash rates by 40% or more compared to the previous year, were ADM Trucking Inc., Bridgestone Americas Fleet Operations LLC, Cooper Tire & Rubber Co., Frito-Lay Inc., Harris Teeter Inc., and Targa Transports LLC.

The Bronze Seal recognition is presented to companies who have reduced their vehicle crash rates by 20% to 39% from the previous year. The winners of the Bronze Seal are ADM Trucking Inc., Bridgestone Americas Fleet Operations LLC, CHS Inc., and Frito-Lay Inc.
