NPTC PROGRAM FOR NSC: THE ROAD AHEAD TO SAFETY

NPTC's National Safety Conference is scheduled for Sept. 13-14 at the Hyatt Regency at Dulles International Airport just outside of Washington, DC. It expects to draw nearly 250 private fleet safety professionals from a wide and diverse spectrum of private fleets and supplier companies that are focused on continuous improvement, innovative safety protocols in driver management, and world-class safety standards.

This conference is designed to optimize return-on-investment for all attendees. It is an intense, concentrated overview of issues of interest and importance to running a private fleet operation at an exceptionally high standard of safety. It features 24 of the leading safety advocates and practitioners in the private fleet community.

NPTC Chair of the Board of Directors and Safety Committee Chair Carol Heinowski, logistics manager, safety & compliance at Meijer Inc., says, "The Safety Conference is just a great venue to learn and network with fleet safety experts who really are on the leading edge of change. Attendees take away dozens of insights and ideas, which can be readily implemented in their own fleet."

The program begins with a keynote address from Debbie Hersman, former chairman of the National Transportation Safety Board and currently president and CEO of the National Safety Council. NPTC general counsel Rick Schweitzer will then deliver his Washington Report, which is sponsored by Vigillo, a Samba-Safety Company. Next will be presentations on integrating active safety

technology systems into a safety program in addition to driver training and coaching best practices.

After the luncheon and recognition of the National Driver All-Stars, a driver recognition program sponsored by International Trucks/Navistar Inc., the program resumes with two sessions of five concurrent "Safety-in-the-Round" discussions. These open-forum sessions allow participants to share freely their challenges, resources and solutions in an atmosphere of trust and confidence. The first session will feature discussions on enhancing background searches; electronic logging devices; driver scorecarding that enhances safety; road tests that get results; reducing injuries; and workers' compensation. The second session will feature discussions dealing with an aging driver workforce; enhancing safety meetings; surviving a DOT audit; the future of screening protocols; and mitigating distracted driving.

The safety conference resumes the following day with a presentation from highly respected transportation attorney Rob Moseley of Smith Moore Leatherwood LLP. His presentation will be on how to make the bad accident worse, and what makes truck litigation turn sour?

Four presentations will focus on fatigue management strategies; rewards, recognition and incentives; advanced data analytics; and creating a driver turnover risk metric. The conference wraps up with a presentation titled "Case Study in Excellence - Putting It All Together."
