# CTP Exam Grading

These graders literally poured over hundreds of pages of case study analysis to ensure that candidates had developed comprehensive, credible and insightful solutions that demonstrated an understanding of the five key core disciplines – finance, human resources, operations, safety, and equipment and maintenance. Each CTP earned 25 points towards their recertification.

# CTP Exam Validation

We had numerous volunteers who helped validate the multiple choice portion of the exam including: Deb Acierno, CTP; George Carpenter, CTP; Dave Rodenroth, CTP; Louis McAnally, CTP; Rick Gilchrist, CTP; Jeff Bogart, CTP; and John Meyer, CTP. The cut score is the minimum score on an exam that one must receive to become certified.

These volunteers combed through the multiple choice

portion of the exam and evaluated each question in terms of relevance to the task, fairness of the question, and to ensure that the candidates demonstrated proficiency in all five core competency areas of the job: financial, safety, human resources, operations and equipment and maintenance.

This vetting process, in which subject matter experts reviewed the test questions both before and after the exam, ensures the integrity of the testing

process by making sure the questions are relevant to the job of the private fleet professional and are fairly written and understood.

# **Q&A**

Q. How do I best prepare for a DOT audit?

A. Your question could not be more timely. Each year, DOT and its state partners conduct about 10,000 compliance reviews. At the recent Private Fleet Management Institute, Chris Sullivan, CTP, CDS, Corporate Fleet Safety Superintendent for McKee Foods Transportation, shared his experiences of

going through a compliance review at one of his experiences.

# CTP Profile: Patrick Robinson, CTP ~ Boise Cascade Trucking

"It's difficult to be a leader if you don't have all tools." How does your private fleet compare to other transportation alternatives? And more personally, how good are you as an employee? As a member of the private fleet team? As a transportation or private fleet practitioner?

These were just some of the questions swirling through Patrick Robinson's mind three years ago as he began preparations to sit for the CTP exam. His boss at Boise Cascade had achieved the designation in 2004 and had returned and started to institutionalize the process throughout his organization. The next year, Robinson, then a customer service representative and load

planner, attended the Private Fleet Management Institute before sitting for and passing the CTP Exam in 2005.

Life for Robinson, or for Boise Cascade, hasn't been the same since. "As a result of achieving my CTP designation, I earned a promotion and a bump in pay grade," says Robinson. He was made responsible for three profit centers within the trucking group. He has helped the company to build a strong backhaul network that has allowed him to trim empty mileage to 8.1%.

"But more importantly was that it broadened my perspective and allowed me to grow internally. Before the CTP, I was happy operating in my narrow little band. But participating in the Private Fleet Management Institute and earning by CTP designation exposed me to different aspects of private fleet management that have been invaluable to me in my professional journey. Simply put, it's difficult to be a leader if you don't have all tools."

Robinson was recently elected to the Board of Governors for the NPTC Institute.
