## **2011 CTP Exam Results**

On Saturday, February 13, 54 candidates sat for the prestigious Certified Transportation Professional exam in 24 locations. This is the highest number of candidates to sit for the exam since the 1990s. This year, we replaced the multiple choice portion of the exam with a shortanswer essay portion, as the Institute Board of Governors believes this more accurately reflects the skills and knowledge necessary to demonstrate

proficiency in the key private fleet management disciplines.

Thirteen candidates chose to sit for the retake exam on March 17, and of those sitting, 11 passed both portions of the exam. This brings the total number of CTPs in the Class of 2011 to 49, the third largest in the history of the program

**Q.** What is NPTC's position on the Federal Motor Carrier Safety Administration's efforts to modify the current driver's hours of service?

A. In comments filed last month with FMCSA, NPTC strongly opposed the agency's proposal to modify the existing hours of service and urged it to keep the current hours of service rules in effect with the exception of the sleeper berth provision.

"FMCSA has assumed that the proposed changes will improve motor carrier safety despite contrary evidence, existing safety records and the agency's prior policy statements," NPTC said. "The current HOS regulations have not harmed motor carrier safety as many opponents predicted. In fact, these regulations have contributed to a remarkable and unprecedented improvement in crash and fatality rates involving heavy trucks."

Under the current proposal, FMCSA is, among other changes, considering whether to reduce the daily driving limit from 11 hours to 10 hours and has proposed to limit the 34-hour restart provision by requiring that it include two periods from midnight to 6:00 a.m. and limiting its use to once per week.

As the livestock production subsidiary of Smithfield Foods, Inc., Murphy-Brown, LLC is the world's largest pork producer. Murphy-Brown is committed to producing high-quality products while protecting the environment and preserving family farms. In the United States, the company owns approximately 818,000 sows and brings more than 17 million hogs to market annually. Operations include 450 companyowned farms and approximately 1,500 contract swine growers. Headquartered in Warsaw, N.C., the company boasts approximately 5,000 employees in 11 states. Operating quietly but effectively behind the scenes is the company's

direction of Robert W. Slaughter, CTP, director of animal transportation. The private fleet exists to provide the sows, baby, pigs, feeder pigs and market hogs with food and to move animals through the various stages of production, and ultimately, to processing plants.

The fleet faces continued pressure on the bottom line from rising energy and grain prices. Slaughter says his CTP background provides solid information to tackle these problems.
