ALL-TIME ATTENDANCE RECORD IN JACKSONVILLE!



Icing On The Cake

THIS YEAR'S NPTC/FLEET OWNER MAGAZINE'S "TOP GRADUATE" of the CTP Class of 2020 is **Michael Shafer, CTP**, Senior Logistics Analyst at Core-Mark International.

A leader in convenience store delivery, Core-Mark International is one of the largest distributors and marketers of consumer goods in North America, distributing fresh, chilled, and frozen merchandise to some 45,000 customer locations.

Core-Mark has a strong and well-regarded private fleet. According to Michael's boss, **Brian Johnston, CTP**, Senior Director of Transportation and member of the NPTC Board of Directors, "the top executives of our company truly believe the private fleet is a competitive advantage." The fleet serves 30 distribution centers with 1800 drivers, 1200 tractors, 150 straight trucks, 1550 multi-temp trailers, and 220 CGN tractors. The company has one of the most innovative driver performance measurement and improvement programs in the private fleet industry. Michael Shafer is part of a data and technology management team which helps contribute to the success of this program.

Born and raised in Houston, Texas, Mike enrolled in Texas Christian University and majored in supply chain management with an accounting minor. While on campus, he joined the Phi Mu Alpha Sinfonia Fraternity of America, a small music fraternity, and went country dancing almost every weekend.

He had two internships while in college. The first was working for L'Oreal in Dallas after his junior year, and then travelling to Moberly, Missouri, to work for Walmart at one of their grocery distribution centers. After graduating from TCU, he was hired by Core-Mark International and placed in the Sanford, North Carolina Distribution Center as an Operations Analyst.

"I loved my time in Sanford and made many lifelong friends through tennis or Karaoke on weekends," says Mike. "My job in Sanford consisted of finding areas of the operation, both on the warehouse and transportation sides, that could benefit from time efficiencies through the use of analytical tools." Mike was later hired by Brian Johnston, CTP, to join the Corporate Operations team as a Logistics Analyst to provide support of all Core-Mark Divisions across the U.S. and Canada.

With this promotion came extensive travel. To save time on travel, but most importantly to return to Texas where he went to school and be closer to family, Mike relocated to Fort Worth, Texas.

"I was first introduced to the NPTC at the 2017 Annual Conference in Cincinnati. This was my first chance to see how private fleets can be effective in a wide range of industries," said Mike, "This experience also gave me insight into the unique learning culture of the Council."

"My participation in the Private Fleet Management Institute three years later was eye-opening. It felt a little daunting at first because others in the class had broader and more extensive experience in transportation. Several managed private fleets. Together, the attendees and faculty members truly brought an incredible depth of knowledge and experience to the program."

Mike quickly adjusted and found both general and breakout sessions valuable exercises in learning and sharing. He was especially impressed with the managers and suppliers with expertise in his line of work: data analytics and the management of technology rollouts.

"The networking opportunities at PFMI were unbelievable. I met dozens of professionals I probably would not have met anywhere else," said Mike. "My time preparing for the CTP exam can be summed up as both incredibly stressful and highly rewarding. I read the resource guides before attending the Institute which helped me learn how to study again."

"The late-night studying and practice exams might've kept me up a few nights too many, but the connections I made at the PFMI and the final result of the exam are some of the highlights in my logistics career," said Mike. He remembers the exact moment when he found out he passed the CTP Exam and earned the highest grade in the class to become "Top Graduate".

"I was at my desk at work concentrating on a big conference call. A "Congratulations" email popped up which I couldn't get to until I got off the call. When I read 'Top Graduate' the third line down I felt like—wow—this is icing on the cake.

I am humbled by this honor and proud to be a Certified Transportation Professional®."



CTP EXAM RESULTS

ON SATURDAY, FEBRUARY 8, 93 CANDIDATES SAT for the 2020 Certified Transportation Professional exam at a record 46 locations. Of the 93 that sat for the exam, 73 passed both portions – a 78% pass rate which is in line with our historical pass rate of 76-79%. The top graduate was **Michael Shafer, CTP**, Senior Logistics Analyst of Core-Mark (see profile elsewhere in this issue).

Of the 20 who failed: 8 candidates failed both portions of the exam; 9 failed the short answer essay only; 3 failed the case study only. The retake exam was held on March 14 and of the 19 candidates that sat for the retake exam, 17 passed, bringing the CTP Class of 2020 to 90. Members of the class of 2020 are:

CANCELLATION OF NPTC 2020 ANNUAL CONFERENCE IS OFFICIAL

Upon recommendation and approval of NPTC's Treasurer and General Counsel, the Executive Committee of the NPTC Board of Directors has cancelled the NPTC 2020 Annual Conference and Exhibition.

This decision was made in the best interest of the safety and welfare of all parties involved. It is also in response to the Governor of Ohio's State of Emergency orders recommending and then prohibiting mass meetings scheduled in the state be cancelled, as well as the fact the World Health Organization has declared the COVID-19 crisis officially a pandemic and the U.S. government has banned travel from European Union countries into the United States. Many local and state jurisdictions around the country have issued orders recommending or requiring cancellations or limits on participation in all non-essential mass meetings.

with comparative metrics to quantify the superior customer service, driver dependability, cost, and safety which the fleet provides versus outside carriers.

Upon request, NPTC provides participating companies with a customized data analysis showing how their individual data compares with the aggregate data of comparable companies in their field, as well as a comparison with the overall national data collected for all private fleet respondents to the survey. Dozens of companies contributing to last year's survey report took advantage of this value-added service.

NPTC understands the essentiality of keeping your responses completely confidential. Your company's name, individual data and your responses will remain anonymous and will not be disclosed in any way or shared with other companies. Rather, they will be combined with the results of other fleet members to produce "a state of the industry" report based on aggregated data and analysis.
