# "Following in the Footsteps of His Father"

AUL MILLER, CTP, FOLLOWED IN THE STEPS of his father who worked 41 years in the food distribution business based in Buffalo, New York, where Paul was born and raised. During his high school years, he worked for supermarkets in the area driving straight trucks making deliveries to local stores.

On the side, Paul also worked selling merchandise part-time for the Buffalo Sabers Hockey team, the Buffalo Braves basketball team, the Ice Follies, and later sold programs for the Buffalo Bills. This led to a full time job "on the road" as a truck driver delivering merchandise to rock concerts performed by groups like the Eagles and Billy Joel.

"In one of the Eagles' long-running tours covering 40 straight days and nights," says Paul, "I delivered the band's customized merchandise (T-shirts, CDs, caps, group photos of the band in concert, etc.) to twenty-five

separate concerts. Back in the 1970s and 1980s, bands took great interest in merchandise sold at their concerts because the profit was considerable. \$100,000 in T-shirt sales at a concert was pretty common back then," says Paul.

After a few years of this exciting work lifestyle, Paul accepted a management job with the Kroger company and moved to Houston where he stayed for two years in various warehouse and transportation positions before accepting a position with the Randalls Food Market chain (later purchased by Safeway). After holding a variety of progressively more responsible positions at Randalls for 15 years, Paul was recruited by Merchants Distributors in a position handling both warehousing and transportation.

In 2002, he was promoted to Director of Transportation. By this time, Paul had more than twenty years of management experience in transportation and had completed both associate and bachelor degrees in business. With this advancement, and with the encouragement of a colleague who had been active with NPTC

> for many years, Paul took an interest in pursuing the CTP program and attending the Private Fleet Management Institute.

In 2004, Paul sat for the CTP Examination and graduated with the CTP Class of 2004. After he earned his CTP, he started coming to the Annual Conference and other events every year or every other year. He also sent other people at the company to NPTC events.

"NPTC does a better job in transportation management training and qualification than any group in the industry. The CTP

program is the icing on the cake." says Paul. "In addition to the meetings, off-line conversations with trusted NPTC members provide an invaluable business network of contacts."

Following in father's footsteps now carries on to a third generation. One of Paul's three sons is already a truck driver and another, recently retired from the U.S. Coast Guard, is considering becoming a professional driver as well.

"Maybe one will end up in transportation management and earn his CTP," says Paul.

"That would be quite a legacy to pass on."

Topics that will be discussed this coming year include:

#### March 21 "Driver Qualifications"

What is meant by the term "driver qualifications"? There is a large body of regulations devoted to what is involved with qualifying a driver, specifically sections in Parts 382, 383, and 391. However, there is much more to "qualifying" a driver than following the regulations. In this webcast, we will discuss the policies and procedures a carrier should have to make sure that it is not hiring an unqualified driver or its next problem.

#### March 22 "Medical Qualifications/ Sleep Apnea"

Any discussion of sleep apnea needs to begin with what the rule say, and don't say. That discussion must be followed by what the medical examiners have been told and are currently doing. However, that is just the beginning of the discussion when it comes to sleep apnea. Sleep apnea is a "hidden cause of fatigue" that carriers should consider addressing themselves, rather than waiting for an examiner to tell you that one of your drivers is at risk.

## May 23 "Hiring Standards: Background Checks"

There are many regulations, best practices, and processes in use for hiring drivers at carriers. Mostly, they all have one goal, and that goal is to hire safe drivers for the company. One key step in any hiring process is conducting thorough background checks. In this webcast we will discuss the required background checks, as well as optional background checks a carrier should consider using to make sure they are hiring safe drivers.

### May 24 "Hiring Standards: Screening Protocols"

With the driver shortage leading to more expansive recruiting efforts and the temptation to lower hiring standards (potentially leading to hiring more problems), it is more important than ever that carriers review their hiring process. In this webcast we will look at the requirements involved in screening and qualifying a new driver, methods to do it quickly and effectively, and strategies that can be used to keep you from "hiring your next problem."

## July 17 "Entry Level Driver Training and Onboarding"

A driver's basic job is to get from origin to destination without loss, damage, or delay. This means knowing where you are going, counting and securing your cargo (or actually loading it in certain situations), inspecting your vehicle when required to make sure it keeps running and is safe, driving safely, complying with the applicable regulations, and delivering your cargo on time and in good condition, and completing the necessary paperwork along the way. To be able to accomplish all of these tasks safely and efficiently, drivers must be trained by their carriers. How and when you conduct that training is up to you. In this webcast, we will look at what a driver training program should include, how the training should be delivered, and establishing a training schedule.

# July 18 "Driver Scorecarding and Development"

Once developed, an effective score card can be used as the basis for bonus and incentive programs, as a driver development and improvement tool, and as a mechanism to compare the driver's performance to on-going employment standards. However, an ineffective scorecard can lead to confusion, the wrong message being sent to the drivers, and even unneeded driver turnover. In this webcast we will discuss how to develop and implement an effective driver scorecard and how to avoid pitfalls that can create problems with the scorecarding.

### October 17 "Hours of Service – Fatigue Management"

In this session we will discuss the hoursof-service regulations as they stand today and any official action that might be underway to change them. We will also look at other methods used counter fatigue, and where information can be found to help you develop a cohesive fatigue management program.

### October 18 "How to Survive a DOT Audit"

In this webcast we will discuss the different types of investigations conducted by the Federal Motor Carrier Safety Administration (FMCSA) and the regulations and processes involved in a FMCSA investigation (audit), including:

- The selection process used by the Federal Motor Carrier Safety Administration to select carriers for investigation
- The "six factors," including the required records used in each factor
- The selection method used by the investigator when deciding which drivers and vehicles to audit

• The audit scoring/carrier safety ratings We will also discuss the how to prevent an audit, latest news related to auditing, the top violations discovered during audits, and the steps necessary to be prepared for an audit.
