Free Webcasts for 2020 Announced!



NPTC AND J.J. KELLER & ASSOCIATES, INC., have announced the lineup of topics for the 2020 webcast series that are free to all NPTC members.

#### **March Webcasts**

March 18, 2020: FMCSA's New Drug And Alcohol Clearinghouse. Effective January 6, 2020, the Federal Motor Carrier Safety Administration's Drug and Alcohol Clearinghouse began requiring FMCSA-regulated motor carriers, Medical Review Officers, Substance Abuse Professionals, and private, third-party USDOT drug and alcohol testing management companies to record information about a driver who fails a drug and/or alcohol test; refuses to submit to a drug and/or alcohol test; and successfully completes a substance abuse program and is legally qualified to return to duty. It also requires carriers to "query" that database for drivers they employ. In this webcast, we will cover the motor carrier requirements and processes for making entries and queries.

March 19, 2020: Driver Qualification And Screening. What is meant by the term "driver qualifications"? There is a large body of regulations devoted to what is involved with qualifying a driver, specifically sections in Parts 382, 383, and 391. However, there is much more to "qualifying" a driver than following the regulations. In this webcast, we will discuss the policies and procedures a carrier should have to make sure that it is not hiring an unqualified driver or its next problem.

#### **May Webcasts**

May 20, 2020: Using DataQs To Challenge Accident Determinations. As FMCSA has made the crash preventability demonstration program permanent, it has become incumbent that motor carriers understand how the program works. In this webcast we will review what FMCSA considers an accident, how carriers are to record them, and the process of challenging the DOT classification of the accident via the FMCSA's DataQs website. We will then discuss why a carrier should participate in the preventability program, and when and how a carrier can request that a crash be considered "not-preventable."

May 21, 2020: Accident Protocols. The worst has happened. One of your drivers has been involved in a serious accident. Now what? So many things need to be done correctly, and one mistake can have catastrophic consequences. In this webcast we will look at the steps you should take to prepare for a serious accident; what you need to do in the first critical hours after the accident; and what you need to do in the weeks, months, and even years that follow.

#### **July Webcasts**

July 15, 2020: Roadside Inspections. A roadside inspection is a high-stress, and sometimes confusing and even mysterious experience for your driver. Having the driver knowledgeable and comfortable with the roadside inspection process can improve the outcome in a lot of cases. This webcast will provide carrier personnel with knowledge that can be shared with the drivers to help reduce the stress and the mysteries when it comes to roadside inspections and help improve the outcomes when it comes to them. In this webcast will discuss:

- How drivers and vehicles are selected for inspection;
- The regulatory issues that are being looked at during the inspection, including electronic logs;
- The process and procedures involved in the inspection;
- What will be asked of the driver; and
- Most importantly, how and why to share this information with your drivers.

July 16, 2020: How To Survive A DOT Safety Audit. In this webcast we will discuss the different types of investigations conducted by the Federal Motor Carrier Safety Administration (FMCSA) and the regulations and processes involved in a FMCSA investigation (audit), including:

 The selection process used by the Federal Motor Carrier Safety Administration to select carriers for investigation

- The "six factors," including the required records used in each factor
- The selection method used by the investigator when deciding which drivers and vehicles to audit
- The audit scoring/carrier safety ratings We will also discuss the how to prevent an audit, the latest news related to auditing, the top violations discovered during audits, and the steps necessary to be prepared for an audit.


#### **October Webcasts**

October 14, 2020: Driver Fatigue And Hours Of Service. In this webcast, we will discuss the hours-of-service regulations as they stand today and any official action that might be underway to change them. In addition, we will explore how to deal with unassigned driving time (correctly). Developing a company policy on use of the FMCSA "personal conveyance" guidance promotes efficiency, supports safety and protects your company from litigation. We will also look at other methods used counter fatigue, and where information can be found to help you develop a cohesive fatigue management program. #### October 15, 2020: Medical Qualifications

For Drivers. In this webcast we will be looking at the seemingly ever-changing driver qualifications requirements. We will discuss driver qualification file requirements and updates to background materials that medical examiners use. Finally we will also be looking at present status of, and potential upcoming changes to, the driver qualifications standards, including sleep apnea, insulin dependent diabetes, and monocular vision.

## **Managing Driver Behavior**

S SAFETY COORDINATOR, Brett Pulley, CTP, specializes in driver safety and team member engagement for TBHC Delivers, a division of Lumina Foods, which is the distributor of Hunt Brothers Pizza. He manages the programs and processes that support sustainable improvements in driver performance and risk management.

He also oversees the safety portion of onboarding new team

members, as well as the vehicle operator training program and portions of compliance. Brett works to instill a sense of ownership of safety in each driver and attempts to build that belief structure on a driver-by-driver basis. He is a Certified Smith System Driver Trainer and earned his Certified Transportation Professional (CTP®) designation in 2017. Brett is a frequent speaker at NPTC's National Safety Conference and an active member of the Safety Committee.

Raised in Columbia, Tennessee, located one hour south of Nashville, Brett was inspired to join the military after the 2001 terrorist attacks on our country. He enlisted in the United States Army in 2003 as an infantryman and became a trained member of combat squads which traveled in mechanized

infantry combat vehicles (M2 Bradleys). Brett served in Iraq and completed his four-year tour of duty in 2007.

After his honorable discharge from the military, and with the help of the G.I Bill tuition program and scholarships, Brett enrolled in Lipscomb University, a private Christian liberal arts school in Nashville. He earned a bachelor's degree in business and an MBA in management and soon joined the Hunt Brothers Pizza company where he began building a data base on driver crashes.

TBHC Delivers serves over 3,000 plus stores in 14 states. Pizza ingredients make up about 75% of the cargo hauled. The fleet consists of 80 medium duty trucks, Classes 5-6, which are

top heavy, temperature-controlled vehicles. The company strives to elevate customer service to the highest level possible by being more than a product delivery service. Acting more like merchandisers and marketers, sales associate/drivers are CDL "B" license holders often hired from the non-CLD community. They take inventory, stock shelves, check equipment to ensure it is working properly, and on the way out take out the trash.

"Safety is the highest priority for our company," says Brett. "Over the past five years, we have improved our safety performance and reduced collisions by reinforcing good driver conduct and mitigating behaviors which contribute to the accidents."

Brett has developed a system of analysis and coaching which corrects behavior before an accident happens. They use in-cab cameras in all the trucks. Brett looks at "triggered" videos to highlight good things the drivers are doing as well as areas of needed improvement they often are not even aware of.

A common example is following too close.

"We use the six seconds metric as our following distance. When we find a driver following below this standard, we show him or her how to use the following-distance measurement. We also show that this does not slow the trip down," says Brett, "if we are correctly training to keep space in heavy traffic."

He adds, "A driver operating too fast for conditions may think that high speed is normal, particularly if the driver gets praise from a store manager for beating an on-time delivery window. To reduce this behavior, we praise him for camera events showing safe behavior instead."

The company has a data-based history of collisions involving the fleet. "From this history, we track the cause of the accident, driver behavior (good and/or bad), and corrective action which drivers or the company made afterwards," says Brett.

It is important to verify your reaction is working and to keep good records. What are the outcomes over time? "We record that the driver changed his driving protocol for better, sustainable results. while noting how the company changed its approach to coaching, or introduced enhanced technology like forward collision assist," says Brett.

Brett believes coaching and empowerment are linked. How frequently are drivers shown they did something the way you wanted, and do they understand that was a success? How timely are coaches' reactions to good or bad news? What is your ratio of good news to bad news? How reliant is your coaching regarding mistakes?

"Pointing out mistakes or flaws is part of coaching but alone it is worse than nothing," says Brett. "What they did poorly should be addressed early on and then backed up by things you found they did well.

The goal of coaching is to change behavior which is at the root of problems, but also the path to improvements."

Managing outcomes is key. Brett says he spends considerable time analyzing driver videos "triggered" by significant events. "For instance, 90% of near misses are camera-caught," says Brett, "In our process-based performance management system, the outcomes we coach for are prevention in the future.

"The camera is an enemy for some, but not for long. When they see themselves in videos doing so many things right, it affirms professional pride and accomplishment. Videos also help drivers learn something about themselves perhaps they didn't know, or see something they would do better or differently the next time around."



## CTP Recertification

TITS FOUNDING AND FROM THE TIME OF ITS CHARTER CLASS GRADUATION IN 1993, the National Private Truck Council's Certified Transportation Professional (CTP ®) program's guiding vision was to create a widely recognized and respected credential of professional achievement for private fleet managers and suppliers. By earning your Certified Transportation Professional (CTP) designation, you joined a group of transportation professionals who have made the commitment to the private fleet industry, to an ongoing pursuit of career advancement, and to continuous enhancement of the necessary knowledge and skills. You should feel proud of the accomplishment you have achieved for both yourself and your company and a designation you will want to keep for your entire career.



In order to maintain your certification in the program, there are several points you must remember:

- CTPs must recertify every three (3) years;
- •50 recertification points must be earned during the 3-year period (to check your current point balance and recertification

year cycle, <u>click here</u>);

• A Recertification Application need only be filed once during the 3-year period to register recertification points or may be

filed annually; and,

• Recertification Applications are available for completion online (*click here*). (For a matrix of opportunities to earn points, *click here*.)

Earlier last month, you received your annual \$100 invoice required to maintain active status. While your company may pay your annual \$100 fee, ultimately you are responsible for payment of this fee as the certification is a personal designation. You can pay your \$100 CTP annual fee *online here*.

Aside from the prestige of holding the industry's highest certification achievement, CTPs receive:

- The NPTC Weekly Update, a comprehensive summary of current legislative & regulatory issues that affect private fleets
- More educational programs that reach beyond your current level of achievement and allow for continued advancement
- Increased opportunities for networking with fellow CTPs
- Access to our Training and Certification specialist to answer all questions relating to private fleet operations




