NPTC NATIONAL SAFETY **CONFERENCE CONTENT**

NPTC's National Safety Conference, scheduled for September 11-13, expects to draw nearly 250 private fleet safety professionals from a wide and diverse spectrum of private fleets and supplier companies focused on continuous improvement, innovative safety protocols in driver management, and world-class safety standards.

The conference, which is designed to optimize return on investment for all attendees, is an intense, concentrated overview of key issues of interest and importance to running a private fleet at an exceptionally high standard of safety. It features 24 of the leading safety advocates and practitioners in the private fleet community.

"The Safety Conference is just a great venue to learn and network with fleet safety experts who really are on the leading edge of change," said Carol Heinowski, NPTC Chair of the Board of Directors and Safety Committee Chair. "Attendees take away dozens of insights and ideas which can be readily implemented in their own fleets. These will be reinforced again and again by various fleet examples of how combining the newest equipment technologies with great driver team building is a winning safety strategy." Carol is also the logistics manager of Safety & Compliance at Meijer Inc.

The program promises to deliver insights, resources, and leading management protocols that will help private fleets enhance their safety effectiveness. It begins in the afternoon

on September 11 and will conclude at noon on September 13. The program will feature a series of general sessions, business networking sessions, and roundtable discussion forums delivered by a faculty of the nation's leading safety practitioners.

Topics to be addressed include safety technology; compliance issues; regulations; driver hiring, screening, and training; workers' comp; the role of compensation; data aggregation; liability issues; and fatigue management, among others.

For the first time, the National Safety Conference will feature an exhibit hall with an initial 25 exhibit booths. These booths quickly sold out at our Annual Conference in April; however, we have formed a waiting list of interested exhibitors and will announce additional booths available for sale later this month. The site for the National Safety Conference and fall board and committee meetings will be the Omni Orlando Resort at Championsgate. Later this month. NPTC will release its 2019 Benchmarking Survey Report, which examines a number of key operational and performance issues. The report is designed to validate private fleet performance based on comparative peer data, to identify areas of improvement and opportunity, and to highlight significant trends affecting private fleet practitioners.

The benchmarking survey delves into key operational areas such as safety, technology, driver turnover, compensation, operational costs, equipment, and maintenance to identify key trends and best practices.

As in previous surveys, the most common reasons for operating a private fleet are to gain direct control of transportation capacity on demand, to control costs, and to provide consistent and high-quality customer service.

Private fleets stand out as a dynamically growing transportation market. As the largest sector of the trucking industry, they account for approximately 50% of all Class 8 truck sales and own or lease some three out of four Class 4 to 8 trucks on the road. About 40% of all leased trucks are to private fleet companies.

In the last 10 years, the private fleet vehicle count has risen by 50% among the top several hundred companies even as the existing population has become more efficient. And a majority of private fleet managers (more than two-thirds) plan to add trucks to their fleet capacity in the years ahead.

NTSB VICE CHAIRMAN TO ADDRESS CONFERENCE
