## 2019 PRIVATE FLEET MANAGEMENT INSTITUTE

An enormously successful PFMI 2019 held in January in Jacksonville, FL, won enthusiastic endorsement from 110 private fleet practitioners in attendance. This was the second-largest group of attendees in the program's history. A record number of 79 attendees also participated in the CTP Exam Prep Workshop held the day before the PFMI began.
