2011 PRIVATE FLEET MANAGEMENT INSTITUTE

With 81 attendees, the NPTC Private Fleet Management Institute, held January 15-19 in Jacksonville, was one of the highest-rated programs in the history of the Institute. The quality and interest of the attendees, combined with insightful presentations, led to an unprecedented level of interest and engagement as reflected in the evaluations received from the participants. For the first time this year, the program moved to a more interactive discussion group format. This allowed for a concentrated, five-day immersion into the core private fleet management curriculum specifically designed to meet the demanding needs of today's private fleet professionals. The quality of the instruction and training generated outstanding ratings across the board, thanks in large part to the contributions of a faculty consisting of some of the nation's most experienced and respected private fleet management experts.

The tone of the meeting was set early by Harry Haney, associate director of logistics operations for Kraft Foods Inc. Haney shared how his fleet integrated with other transportation alternatives to deliver exceptional value.

Attendees wrestled with just how to accomplish that goal. Through a series of open forums, fleets discussed various strategies including financial strategies to understand all freight-related costs; the development of appropriate key performance indicators; enhancement of customer service objectives; improvement of safety functions; human resource strategies; and leveraging equipment and maintenance practices to optimize the corporate return on its private fleet investment.

Throughout the five-day institute, attendees were exposed to five core management disciplines of finance, human resources, safety, operations, and equipment and maintenance. Key workshop leaders and speakers included NPTC board vice chair Gary Strausbaugh, CTP, Mennel Milling Co., and treasurer Harry Haney, associate director of logistics operations, Kraft Foods. ■ May 11—The EOBR Rule and E-Logs

The FMCSA issued a sweeping new rule governing the manufacture and use of electronic on-board recorders (EOBRs) in commercial motor vehicles. The rule will require thousands of carriers to install EOBRs and encourage others to install them voluntarily to monitor their drivers' hours of service. This webcast will examine the impact of the EOBR rule, including information on who is affected, when the rule takes effect, the incentives available for EOBR installation, how EOBRs will affect the auditing and enforcement process, the new list of 24 rules that can result in your company being forced to install EOBRs, and what you need to do to stay in compliance.

☐ July 13—Fleet Excellence: Driver Wellness and Sleep Apnea

The FMCSA is planning to move forward on new driver health regulations that will include screening/testing for sleep apnea. At the heart of this issue is what to do about driver wellness. This webcast will feature an overview on FMCSA regulatory measures concerning driver physicals, driver wellness and sleep apnea; creative tactics NPTC members are using to improve driver wellness; and a profile of one NPTC member fleet's driver wellness programs.

□ October 12—Fleet Excellence: Driver Discipline and Coaching

While the economic downturn offered an opportunity to be more selective in driver recruiting and retention efforts, the 100,000+ driver shortage projected by FTR Associates in the next couple of years may cause fleets to re-evaluate driver qualification standards. This webcast will investigate alternatives to lowering your standards, including driver discipline and coaching. We'll cover such topics as temp-to-hire programs, probationary periods, safety equipment (e.g., speed regulators, in-cab video monitoring, text message locking devices, etc.), driver monitoring, ride-alongs, coaching strategies and techniques.
