### 2012 SAFETY CONFERENCE

NPTC will hold its National Safety Conference September 13-14, 2012, at the Hyatt Dulles in Herndon, VA, just outside of Washington, D.C.

"The National Safety Conference is an intense, concentrated overview of key issues of interest and importance to running private fleet operations at an exceptionally high standard of safety," said NPTC president and CEO Gary Petty. "The program includes an update on federal regulations, private fleet case studies, a recap of several leading safety technologies, a recognition ceremony honoring top performing drivers, safety-in-the round breakout sessions, liability mitigation strategies, data mining and predictive modeling, and best safety practices. Speakers are recognized experts, including more than 15 private fleet practitioners who manage outstanding safety programs at their respective companies."

Added Randy Perry, CTP, fleet safety manager for Frito-Lay and chair of the NPTC Safety Committee, "Because of its timely and relevant subject matter and the outstanding lineup of speakers representing various segments of truck safety, this conference promises to be one of the best opportunities to enhance safety performance. Plus, the interaction that occurs throughout the day-and-one-half meeting creates multiple opportunities to discover new safety strategies and tactics."

The conference features a unique format of presentations, discussions with key industry representatives, expert panels, and leading safety advocates and practitioners—all designed to provide attendees with insights into implementing strategic safety programs and lowering the cost of risk. The program kicks off with Anne Ferro, administrator of the Federal Motor Carrier Safety Administration and the government's top motor carrier safety official. She will provide insight into the federal government's safety compliance initiatives.

Attendees will talk about their experiences with a series of advanced safety technologies that include disk brakes, anti-rollover technologies, collision mitigation, lane departure, and in-cab cameras. In addition, conference participants will be provided an inside look at how they can mitigate their accident liability, how they can set up an effective sleep apnea program, and how they can use pre-employment screening to improve driver hiring.

To enhance the level of interaction and take-home value, this year's conference will feature five concurrent, interactive sessions focused on driver distraction, driver coaching and discipline, dealing with interventions, workers' compensation, and benchmarking and safety key performance metrics. Another session will highlight best practices from individual fleet perspectives on a range of issues that include safety incentives, hair follicle testing, driver wellness, shipper liability, behavior-based safety, and training.

As in years past, the conference will be highlighted by the annual National Driver All-Stars recognition ceremony, in which nearly 20 drivers from individual NPTC fleet members will be recognized for their exceptional performance in the fields of safety, compliance and customer service.

## NPTC SAFETY COMMITTEE MEETS IN PENNSYLVANIA

More than 50 private fleet safety professionals gathered a few weeks ago in Allentown, PA, for the NPTC Safety Committee Summer Onsite meeting. Attendees were treated to a tour of the Mack Customer Center in Allentown as well as an in-depth briefing and on-track demonstrations of new truck safety enhancements including:

- □ **New automated transmissions:** A look into the safety and performance contributions.
- □ Enhanced stability control: These systems are designed specifically to help maintain vehicle stability and aid in reducing tractor-trailer rollovers and their related costs. Stability Control is an active vehicle safety system that automatically intervenes if a high rollover risk is detected while driving. If a rollover threat is occurring, the system tries to minimize the rollover risk by automatically reducing vehicle speed.
- □ Collision safety system: This system automatically maintains a safe following distance and helps avoid or reduce the impact of rear-end collisions by active braking as needed.
- □ Advanced electronic braking: An inside look into anti-lock braking system technology, automatic traction control, disc brakes, and other key vehicle control system features to deliver the next generation of braking control. EBS utilizes electronic vehicle control for the braking system. An electronic signal replaces the air signal sent by the brake pedal to activate the brakes, improving stopping distances and braking system performance.

## WEBINARS FOCUS ON IMPLEMENTING DRIVER PERFORMANCE TECHNOLOGY
