#### 2015 BENCHMARKING SURVEY UPDATE

Earlier this month, NPTC released its 2015 Benchmarking Survey Report, which examines a number of key operational and performance issues and is designed to validate private fleet performance based on comparative peer data; to identify areas of improvement and opportunity; and to highlight significant trends affecting private fleet practitioners.

The benchmarking survey delves into key operational areas such as safety, technology, driver turnover, compensation, operational costs, equipment and maintenance to identify key trends and best practices.

As in previous surveys, the most common reasons for operating a private fleet are (1) to gain direct control of transportation capacity on demand, (2) to control costs, and (3) to provide consistent and high-quality customer service.

Private fleets stand out as a dynamically growing transportation market. As the largest sector of the trucking industry, they account for approximately 50% of all Class 8 truck sales, and own or lease some three out of four Class 4 through Class 8 trucks on the road. About 40% of all leased trucks are to private fleet companies.

In 10 years, the private fleet vehicle count has risen by 50% among the top several hundred companies, even as the existing population has become more efficient. And a majority of private fleet managers (more than twothirds) plan to add trucks to their fleet capacity in the years ahead.

#### NPTC/J.J. KELLER FREE WEBCASTS

In July, NPTC and J.J. Keller & Associates offered two webcasts free to NPTC members. "Active Safety Technologies" featured Joe Laskowski, CTP, director of fleet safety & compliance, MedTrans LLC and covered various types of onboard safety systems that manufacturers and aftermarket companies are offering. It looked at the experience of fleets using technologies such as collision warning systems, lane departure warning systems, electronic stability control, automated transmissions, and disk brakes.

"Predictive Analytics and Driving Behaviors" featured Cameron Hafer, DOT Compliance, Driver Development & Transportation Safety for Trans Papa Logistics Inc. This webcast discussed how to use available data to determine which of your drivers are potentially unsafe and how to stop the behavior that is making them unsafe. During the webcast, we looked at driver performance tracking systems that are available on a fleet's existing equipment and in the existing data that is available, as well as additional in-depth systems.

Upcoming webcasts, to be held on October 14 and 15, will focus on CSA updates and successful DataQs strategies, respectively.

In the first webcast, we will provide an update on CSA, and we will be highlighting the past, recent and upcoming changes to the CSA program, as well as the increased use of the focused off-site investigations and the cooperative safety plan intervention options, the status of the crash preventability study, and the safety fitness determination proposal. We will also look at strategies carriers can use to hopefully prevent being selected for an intervention.

The second webcast will explore FMCSA's DataQs system, which allows you to request and track a review of Federal and State data issued by FMCSA that you feel may be incomplete or incorrect. Failing to use the system can impact your scores in CSA, as well as give officers on the road and investigators at the FMCSA the wrong impression of your company. In this webcast, we will discuss how to spot something that should be in your data or that is incorrect, how the DataQs process works, and the tactics that should be used to be successful when filling a DataQs challenge.
