#### **NPTC ANNOUNCES 2010 SAFETY AWARDS**

NPTC offers four recognition awards to deserving individuals and companies for their loyalty, hard work and accomplishments.

• DRIVER HALL OF FAME: The NPTC Driver Hall of Fame, co-sponsored by Bridgestone Bandag Tire Solutions, honors four exceptional drivers. In order to qualify, a driver must have driven 2 million mi. and 20 years, or have 50,000 hours with no preventable accidents. Applicants must be regularly employed full-time, leased or dedicated drivers of an NPTC member company and actively driving until time of induction. Applications must be postmarked by Jan. 8, 2010.

• NPTC HUMANITARIAN AWARD: This award will recognize any individual who has demonstrated a continuing voluntary commitment to improving the human condition. Applications must be postmarked by Jan. 8, 2010.

▶ FLEET SAFETY AWARDS: Co-sponsored by Bridgestone Bandag Tire Solutions, these awards recognize fleets for outstanding and/or improved safety records based on their crash rates. Applications must be postmarked by Jan. 29, 2010.

▶ FLEET GRAPHICS AWARDS: The NPTC 2010 Private Fleet Graphics Awards recognize eye-catching fleet graphics that feature cost-effective advertisements for a company's products; and sharp, professional designs that help establish a positive public image for fleet owners and operators. The contest recognizes three grand prize winners as well as the five best entries for both combination vehicles and straight trucks and vans. Applications must be postmarked by Jan. 8, 2010.

### PFMI FEATURES IN-DEPTH TRAINING, ALL-STAR FACULTY

NPTC will hold its annual Private Fleet Management Institute (PFMI) Jan. 16-20, 2010, at the Crowne Plaza Jacksonville Riverfront Hotel in Jacksonville, FL. PFMI is a five-day intensive educational program offering courses on fleet finance, operations, legal, regulatory and safety compliance, human resources, maintenance and equipment.

"The NPTC 2010 Private Fleet Management Institute is a great learning opportunity packed with tremendous take-home value," said Gary Strausbaugh, CTP, chairman of the NPTC Institute Board of Governors and vice president of transportation at Mennel Milling Co. "In today's turbulent economic environment, private fleet managers must look for new ways to enhance their operating knowledge and expand their personal and professional effectiveness. The Private Fleet Management Institute provides the resources and tools to capture, translate and enhance the private fleet value proposition."

The five-day Institute is an immersion into best practices, benchmarking and operational excellence in the private fleet community. Attendees will learn how to develop an effective safety program and how to survive a DOT compliance review. The program provides an excellent resource for those studying to take the Certified Transportation Professional certification exam scheduled for Feb. 13, 2010. In fact, PFMI is preceded by a full-day workshop to help candidates prepare for the exam.

## **NPTC OPPOSES UCR**

NPTC has gone on record as opposing the proposed fee increases published by the Federal Motor Carrier Safety Administration for the Unified Carrier Registration Plan and Agreement. NPTC opposes the proposed fee levels for several reasons. First, the proposed fee increase of 122% is unreasonable and therefore violates the UCR Act. Second. the FMCSA and the states have simply transferred the risk of widespread noncompliance to the carrier registrants, i.e., if certain affected carriers do not pay the fees, the states want to raise the fees on the remaining carriers that have lawfully paid the fees. And third, the state recipients of UCR fee revenues have not shown they are using an amount at least equal to the registration fee revenue for motor carrier safety programs, enforcement or the administration of the UCR Plan and Agreement, as required by the UCR Act. #### **CSA 2010**

NPTC is also closely monitoring the Comprehensive Safety Analysis (CSA 2010). This joint initiative between the Federal Motor Carrier Safety Administration and industry and state partners is working to reduce commercial motor vehicle crashes, fatalities and injuries. CSA 2010 is a proactive approach by FMCSA to reduce losses compared to the current assessment system that waits for a carrier to incur accidents and violations and then reacts with a compliance review.

Specifically, CSA provides the government with the ability to increase the opportunity to have contact with more carriers and drivers. In addition, it will use more and better data to improve performance measurements for identifying high risk carrier and driver behaviors. Finally, it will apply a wide range of interventions to correct these high risk behaviors before they become chronic and habitual.

The program is intended to boost the efficiency and effectiveness of FMCSA's enforcement and compliance program by leveraging the use of technology by using safety performance data collected at roadside and through crash reports to identify unsafe carriers and drivers and to pinpoint their safety performance problems. The more precise assessment will enable FMCSA and its state partners to employ the right tool to address the identified safety problems, resulting in more efficiency for both the agency and the carrier.
