NPTC ANNOUNCES 2011 SAFETY AWARDS

PTC offers four recognition awards to individuals and companies for their loyalty, hard work and accomplishments.

□ FLEET SAFETY AWARDS: These awards, co-sponsored by Bridgestone Bandag Tire Solutions, recognize fleets for outstanding and/or improved safety records based on their crash rates. First, second and third place awards are given for large and small fleets in each of the three operational categories (local, regional, mixed). These awards also present Gold, Silver and Bronze Seal Certificates to private fleets that have reduced their vehicle accident frequency rates. Applications must be postmarked by Friday, January 28, 2011.

□ DRIVER HALL OF FAME: The NPTC Driver Hall of Fame, sponsored by Bridgestone Bandag Tire Solutions, honors four exceptional drivers each year. A driver must have driven two million miles, 20 years or 50,000 hours with no preventable accidents. Drivers must be a regularly employed full-time, leased or dedicated driver of an NPTC member company who is actively driving until time of induction. Applications must be postmarked by Friday, January 14, 2011.

□ NPTC HUMANITARIAN AWARD: This award will recognize any individual from an NPTC member company who has demonstrated a continuing voluntary commitment to improving the human condition. Applications must be postmarked by Friday, January 14, 2011.

IN-DEPTH TRAINING, ALL-STAR FACULTY AT PFMI

NPTC will hold its annual Private Fleet Management Institute (PFMI) January 15-19, 2011, at the Omni Jacksonville Hotel in Jacksonville, FL. PFMI is a five-day intensive educational program offering courses on fleet finance, operations, legal, regulatory and safety compliance, human resources, maintenance and equipment.

"The NPTC 2011 Private Fleet Management Institute is a great learning opportunity packed with tremendous take-home value," said Bedford Monday, CTP, chairman of the NPTC Institute Board of Governors and logistics manager for Schwan's Logistics. "In today's turbulent economic environment, private fleet managers must look for new ways to enhance their operating knowledge and expand their personal and professional effectiveness. The Private Fleet Management Institute provides the resources and tools to capture, translate and enhance the private fleet value proposition."

The five-day Institute is an immersion into best practices, benchmarking and operational excellence in the private fleet community. A faculty consisting of the some of the nation's most experienced and respected private fleet management professionals will guide the learning experience through a series of workshops, panel discussions, lectures and interactive formats designed to enhance the attendees' educational experience and ensure their grasp of key private fleet management disciplines.

Specific sessions will focus on network analysis; supply chain integration and strategic partnerships; justifying the private fleet through proper costing methodologies; best practices in customer service; fleet planning; benchmarking strategies to improve the private fleet; and transportation alternatives. Four of the most pressing challenges facing private fleet operations—data management and integration, fuel economy, backhaul optimization, and environmental stability—will be featured in multiple presentations.

Financial strategies for the private fleet executive will be another area of concentration with topics to include communicating private fleet value; financial models for the private fleet; profit center vs. expense center; financial reporting and budgeting; key performance indicators; and return on investment measures. The Institute will also feature an in-depth look at maintenance strategies for the private fleet including establishing a system for compliance; managing multiple sites; trade cycle strategies; improving fuel economy; and outsourcing strategies. Other topics will include recruiting, hiring, and developing drivers; driver compensation; incentives; and scorecards. On the safety front, attendees will learn the basics of how to develop an effective safety program and how to survive a DOT compliance review.

The program provides an excellent resource for those studying to take the Certified Transportation Professional certification examination scheduled for February 12, 2011, at some 40 locations across North America. In fact, the Private Fleet Management Institute is preceded by a full-day workshop to help candidates prepare for the exam.
