PRIVATE FLEET MANAGEMENT INSTITUTE

A near-record attendance of more than 80 private fleet professionals attended the Private Fleet Management Institute in Jacksonville last month. Distracted driving has become a major safety and regulatory issue. Many studies are now indicating that in-cab distractions account for an ever-increasing number of crashes.

☐ May 15 — Effective Driver Vehicle Inspections

Poor results on roadside inspections are your invitation to a DOT intervention. But it's not just about what the DOT finds. From a risk management perspective, making sure your inspection, repair and maintenance processes and records are in order is your best defense to prevent accidents and mitigate exposure when they do happen.

□ July 10 — DOT Drug & Alcohol Testing

Among the most frequently cited violations found during DOT compliance reviews are violations of the drug and alcohol testing regulations. Pre-employment, random, and post-accident testing are always near the top of the list.

☐ October 2 — Physical Qualification of Drivers: DOT Physicals, Med Cards, Functional Capacity Testing

Statistics from the National Institute of Health paint a grim picture: 54% of male truck drivers smoke cigarettes; 92% don't exercise regularly; 50% are overweight; and 66% are unaware they have high blood pressure.
