# **NATIONAL SAFETY CONFERENCE 2009**

According to the 2009 Benchmarking Survey, NPTC members continue to improve their safety performance. But that doesn't just happen. It takes a dedication to learning new strategies and best practices from best practices in the industry

Just such an opportunity for peer-to-peer learning and exchange took place Sept. 10-11 at the Dulles Hyatt in Herndon, Va., where more than 120 fleet safety professionals convened for NPTC's National Safety Conference.

The conference started with an inside look at how two private fleets improved their safety performance by creating a culture of safety. Both **Thomas M. Christian, Jr., CTP,** of ThyssenKrupp Safway Inc., and **Andy Boehme,** of ADM Trucking Inc., said that safety must begin with a commitment from the top and extend through the hiring, training, coaching, and performance review processes.

They were followed by a session based on the new book, Safety for the Long Haul, in which author **Dr. Ron Knipling** and ATA vice president **Dave Osiecki** discussed crash risk factors, driver errors and other crash triggers, and multi-faceted crash countermeasures.

**Dr. Anne T. McCartt, PhD,** of the Insurance Institute for Highway Safety, spoke about changes the industry can make now to improve commercial vehicle safety.

She was followed by two representatives from the FMCSA Office of Analysis, **Chris Flanigan** and **Jeff Loftus**—who walked attendees through the federal government's process of evaluation of active safety.

Another session focused on the Comprehensive Safety Analysis (CSA 2010). Here **Dave Helge, CTP,** of Idealease of North America, and **Bill Coleman,** of the Federal Motor Carrier Safety Administration, spoke about how FMCSA plans to develop more effective and efficient methods for FMCSA, together with industry and state partners, to reduce commercial motor vehicle crashes, fatalities, and injuries.

**Jim Noble** of Zurich Services Corp. showed how to use the NPTC Best Practices Safety Guide to identify any gaps and opportunities in existing fleet risk management approaches by investigating performance in a number of safety-related areas.

**Stephen B. Chewning, CDS,** of Forcon International Corp., showed how accident investigations can go wrong by either ignoring or not seeing crash scene evidence.

The conference concluded with a session by **Scott Carey** of Baker, Donelson, Bearman, Caldwell & Berkowitz, PC, about how private fleets could mitigate the virtual explosion in litigation from overzealous attorneys seeking to recover real or perceived losses on behalf of their clients.
