NPTC NATIONAL SAFETY CONFERENCE A SUCCESS

Last month, more than 220 private fleet safety professionals attended the NPTC 2016 National Safety Conference where they learned about safety issues of critical importance to private fleet operators.

Leading off the event was Earl Weener, a member of the National Transportation Safety Board, speaking on the subject of "NTSB and the Most Wanted List." His presentation was followed by Jeff Burns, a partner in the law firm of Dollar, Burns, & Becker and one of the most respected "pro-safe trucking" truck crash plaintiff's lawyer-litigators in the United States. The morning was rounded out with presentations from Mike Noble, senior director, Private Fleet Safety, Wal-Mart Transportation.

Highlighting the day's program was the National Driver All-Star Luncheon and Recognition Ceremony sponsored by NPTC and International Trucks/ Navistar.

NPTC HONORS DRIVER ALL STARS

Twenty-seven private fleet truck drivers who have demonstrated high performance standards against their peer drivers throughout the country based on customer service, safety, adherence to company standards, regulatory compliance, and community service have been honored by the National Private Truck Council as National Driver All-Stars. Co-sponsored by International Trucks/Navistar Inc., the award was presented at a ceremony that took place in September in conjunction with NPTC's National Safety Conference. - Compliance with company standards (attendance, attendance at safety meetings, training, paperwork, etc.)
- Regulatory compliance (hours of service, DVIR, MVR, etc.)
- Community service
